I. Call to order:

III. Approval of minutes from last meeting:

A motion was made by Commissioner Mendres and seconded by Commissioner Bruno to approve the minutes of the monthly meeting held on September 15, 2022. All Commissioners present in favor. One Commissioner absent. Motion passed.

A roll call vote was taken. Commissioners Turi, Bruno, Mendres, and Donnelly voted Yes. Commissioner Pearson was absent. Motion passed.
- Upon a motion made by Commissioner Mendres and seconded by Commissioner Bruno a resolution was made to override the state mandated 2% cap for the 2023 budget if needed. A roll call vote was taken. - A motion was made by Commissioner Bruno and seconded by Commissioner Mendres to hold the chief's election on December 8, 2022 from 4-8 PM. The following members will be placed on the ballot – Luke Wade – Chief, Peter Easop – 1st Asst. Chief, Daniel Graham – 2nd Asst. Chief. A roll call vote was taken. Commissioners Turi, Bruno, Mendres, and Donnelly voted Yes. Commissioner Pearson was absent. Motion passed.
