# **Meeting Minutes**

July 21, 2022

## l. Call to order:

## III. Approval of minutes from last meeting:

A motion was made by Commissioner Mendres and seconded by Commissioner Bruno to approve the minutes of the monthly meeting held on June 16, 2022. All Commissioners present in favor. Motion passed.
